Dear Dr. Cho:

This letter is written to advise you that the denial of reaccreditation of International Mid Pac College by the Accrediting Commission of the Accrediting Council for Continuing Education & Training (ACCET) has been affirmed by the ACCET Appeals Panel at its November 30, 2010, hearing, and is now a final action. The Accrediting Commission denied the reaccreditation of International Mid Pac College in its letter dated September 3, 2010, citing three findings of non-compliance, along with specifying an opportunity to appeal the decision. The institution submitted its request to appeal, and subsequently submitted its appeals brief, dated November 5, 2010. The institution's appeals brief also indicated that the institution elected not to appear before the Appeals Panel on November 30, 2010, at which time the panel affirmed each of the Commission's findings, as referenced in the enclosed November 30th Decision of the Appeals Panel; therefore, the decision to deny the institution's reaccreditation is a final action.

Since the institution no longer has accredited status with ACCET, it must take timely steps to insure that any website references, brochures, catalogs, advertisements, letterhead, certificates or other documentation used by the institution, which make reference to ACCET and/or the institution's prior accredited status with this agency, are corrected, removed from circulation or destroyed, no later than 14 days from receipt of this letter. Further, the previously issued ACCET certificates of accreditation must be returned to this office no later than **December 24, 2010**.

As a closing note, the institution has the opportunity to provide a thoughtful and civil narrative to the Commission's action within 15 days of receipt of this letter. ACCET reserves the right to redact any inappropriate or inflammatory comments prior to posting the response on its website. It remains our hope that the accreditation process has served to focus the institution's resources and commitment towards strengthening its operations through the systematic and effective implementation of policies and practices that ensure the highest levels of quality and integrity.
